ORGANIZING THE COMPREHENSIVE LAND USE PLAN (CLUP) AND ZONING ORDINANCE (ZO)
UPDATING TEAM AND TECHNICAL WORKING GROUP

WHEREAS, Sec. 20c of the Local Government Code of 1991 (RA # 7160) mandates the preparation of LGU Comprehensive Land Use Plans enacted through Zoning Ordinances which shall be the primary and dominant bases for the future use of land resources.

WHEREAS, Executive Order No. 72 mandates all LGU to update their Comprehensive Land Use Plans in conformity with the land use planning standards and guidelines prescribed by the Housing and Land Use Regulatory Board (HLURB) and to national policies;

WHEREAS, the Urban and Development Housing Act (UDHA) of RA 7279 gives a clear-cut definition of a Land Used Plan withch the LGUs are mandates to adopt;

NOW THEREFORE, I ANNETTE B. FLORES-BALGAN, Municipal Mayor of the Municipality of Macabebe, Province of Pampanga, by virtue of powers vested in me by law, do hereby order and direct the following:

Section I. Organizing the Planning Team Core Group. The Planning Team shall be composed of the following:

Section II. Technical Working Group (TWG). The TWG shall be composed of the following:

Section III. Function of the Planning Core Group. The Planning Core Group shall perform the following functions:

(i) Coordinate all planning activities and

(ii) Draft and consolidate the contents of the CLUP document.

Section IV. Function of the Technical Working Group. The TWG shall perform the following functions:

(i) Conduct of sectoral / intersectoral analysis, validation and reports;

(ii) Conduct of survey, consultation/ meetings, workshop and

(iii) Integration/ finalization of studies, research findings and consultation/ survey outputs.

Section V. Effectivity. This organization of the Comprehensive Land Use Plan (CLUP) and Zoning Ordenance (ZO) updating Planning Team and Technical Working Group shall take effect immediately.
